GENERAL FUNDS QUARTERLY CASH FLOW

The table below sets forth General Funds Cash Flow first quarter comparisons between fiscal year 2016 (FY16) and FY17. This table reflects a final FY17 cash balance of \$309 million, and pending vouchers and transfers at the Office of the Comptroller of \$4.197 billion.

General Funds' first quarter revenues totaled \$6,927 million, a decrease of \$270 million, or 3.8%, below the FY16 first quarter level, including \$125 million transferred in from the Budget Stabilization Fund that was not repeated in FY17.

FY17 first quarter General Funds' expenditures totaled \$7,616 million, a decrease of \$737 million, or 8.8%, below the FY16 first quarter level.

Income Taxes: Individual Income Tax net receipts through the first quarter decreased by \$169 million, or 5.9% from the FY16 year-to-date level.

Corporate Income Tax net receipts through the first quarter decreased by \$138 million, or 32.3%, from the FY16 level.

Sales Taxes: Sales Tax receipts through the first quarter increased by \$50 million, 2.5%, from the FY16 level.

Public Utilities: Public Utility receipts through the first quarter decreased by \$3 million, 1.5%, from the FY16 level.

Inheritance: Inheritance receipts through the first quarter increased by \$3 million, 3.3%, from the FY16 level.

All Other Sources: All Other Sources are down \$5 million YTD, 3.9%, from the FY16 level.

Federal Revenues: FY17 Federal Sources of revenue through the first quarter increased by \$171 million, or 30.9%, compared to the FY16 level.

Transfers-In: Transfers-in decreased by \$72 million YTD, or 14.6%, compared to the FY16 level.

GENERAL FUNDS REVENUES BUDGETED VERSUS ACTUALS SUMMARY

The table below sets forth General Funds year-to-date budgeted revenues versus year-to-date actual revenues for FY17. Total State Revenues (not including Transfers-In) were \$230 million, or 3.8%, below the budgeted level. Federal revenues were \$105 million, or 12.6%, below the budgeted level.

Income Taxes: Individual Income Tax net receipts through the first quarter were \$149 million, or 5.3%, lower than the budgeted levels. Corporate Income Tax net receipts through the first quarter were \$77 million, or 21.1%, lower than budgeted levels.

Sales Taxes: Sales Tax receipts through the first quarter were \$7 million, or 0.3%, higher than budgeted levels.

Public Utilities: Public Utility receipts through the first quarter were \$16 million, or 7.1%, lower than budgeted levels.

All Other Sources: All Other Sources through the first quarter were \$34 million, or 22.9%, below budgeted levels.

Federal Revenues: FY17 Federal Sources of revenue through the first quarter were \$105 million, or 12.7%, lower than budgeted revenues.

Transfers-In: Transfers-in through the first quarter were \$31 million, or 6.9%, lower than budgeted levels.

GENERAL FUNDS EXPENDITURES SUMMARY

The table below sets forth General Funds expenditures through the first quarter of FY16 and FY17 from appropriations for those fiscal years. General Funds expenditures through the end of the first quarter totaled \$5,798 million, a decrease of \$667 million, or 10.3%, from the FY16 level.

EMPLOYMENT HIGHLIGHTS

The table below sets first quarter employment highlights. Nationally, the unemployment rate in September of FY17 was 5.0%, down from 5.1% during the same period last fiscal year. Illinois' unemployment rate of 5.5% in September of FY17 reflected a decrease from the state's unemployment rate of 5.9% during the same period last fiscal year. Additionally, total nonfarm employment in Illinois increased 43,400 year-over-year, led by increases in Leisure and Hospitality, Other Services, and Professional and Business Services.
